2010 Centennial National Scout Jamboree**



Twin Valley Council Contingent, July 26th through August 4th, 2010

The Twin Valley Council Contingent is seeking Scouts for the 36 youth and 4 adult spots available in the Troop we are sending to the 2010 National Jamboree to celebrate 100 years of Scouting in America!!

Registration for all interested Scouts is online at www.bsajamboree.org which provides a direct link to www.myscouting.org which is where you will actually register online. In order to register, each Scout's PARENT will need to **log in using the parent's member ID number** which is printed on your membership card, or available from the Twin Valley Council registration department by calling 507-387-3124. **The parent or leader must create the myscouting account with their membership number** and then register the youth with the youth's registration number. This is to avoid Scouts registering without consulting their parents. Registration requires a \$10 processing fee. After registration, you will be asked to print out a page and have it signed by your Scoutmaster. Bring the signed copy to the Twin Valley Council office with a deposit for \$300. **Note:** Youth *cannot* have a myscouting account.

Scouts who are age 12 by 1 July 2010 and not yet age 18 by 10 August 2010 are eligible to attend as participants. Scouters age 18 and older have several options to attend the Jamboree as staff for the Jamboree in a variety of areas. Registration for staff is done online as well at www.bsajamboree.org.

Twin Valley Council is seeking adult leaders who will be between the ages of 18-21 during the Jamboree to be 3rd assistant Scoutmasters for the Twin Valley Council Contingent. Cost for the trip including travel, Jamboree fees, and equipment will be approximately \$2,500. There is no cost to register for more information. If you submit an application at www.myscouting.org, there is a processing fee of \$10 that is non-refundable. The initial Jamboree fee is \$300, which is credited to the \$2,500 total cost and refunded if you are not selected to be in the Council Troop. Following acceptance into the Council Troop, you must make \$350 quarterly payments to cover fees and costs of attending the Jamboree. Details will be sent at a later date and everyone will have the opportunity to attend an informational meeting to learn more.
